TO OBTAIN CERTIFICATION (after passing the course):

After successfully completing our nurse aide course, students register to take the state certification test at one of several Michigan testing sites (Kalamazoo County residents take the test at Kellogg Community College in Battle Creek). The testing includes a performance clinical skills test and knowledge test.

FEES: * Training Program - Tuition = **\$700** *(includes the textbook)*
 (NEW POLICY: The full tuition of \$700 is due at the time of registration)
 * Practical Skills Test & WITS Test - paid at time of testing (approximately \$176)

REFUNDS: *There is a \$30.00 drop fee, there is also a late drop fee of \$50.00 if you drop the class within 3 days before the class start date or if you drop on Day 1. There will be NO refunds after Day 1.

REGISTRATION INFORMATION:

The full tuition of \$700 is due at the time of registration. Registration is on a first come, first serve basis until the class is filled. **We do not qualify for FASFA assistance.**

- **Special Learning needs and physical needs should be discussed with instructor before registering.**
- **Residency: You must have lived in Michigan for the past 3 years. If not, you will need to obtain a federal criminal background check BEFORE registering. Call us for info on how to proceed.**
- **Felony: persons convicted of a felony or conspiracy to commit a felony within the past 15 years will not be allowed to enroll. (Public Health Code Act 368).**
- **Misdemeanor: persons convicted of a misdemeanor involving abuse, neglect, assault, battery, or criminal sexual conduct within the past 10 years will not be allowed to enroll. Persons convicted of a misdemeanor involving fraud or theft against a vulnerable adult within the past 10 years will not be allowed to enroll as well (Public Health Code Act 368). Persons convicted of retail fraud within the last 5 years will not be allowed to enroll.**
- **A criminal background check will be performed by Comstock Public Schools on all nurse aide students prior to the first day of class. A "Consent for Criminal Background Check" form must be completed as part of the registration process. Knowingly providing false information is a misdemeanor that carries no more than 90 days in jail or a fine of not more than \$500.00 or both.**
- **Stop by the Comstock Administration & Community Education Dept at 3010 Gull Road (across from the Borgess Fitness Center/Nazareth Complex).**
